# Instructions for Abstract Submission

Abstracts will be reproduced in the *River Crossings: Linking River Communities* Program, distributed to participants, and used by session moderators to introduce you, your fellow speakers and panelists. Please submit an abstract for each solo presentation and panel on which you would like to participate, and for each poster you'd like to display as a separate electronic document in MS Word format. If we receive multiple abstracts for one topic we may ask you to appear on a moderated panel for that topic. While we welcome all posters, we may not be able to accept all presentation abstracts due to scheduling constraints.

#### Submission Guidelines

The page layout for the *River Crossings: Linking River Communities* Abstract is shown in the accompanying MS-Word template. Please prepare your submission according to the instructions.

- Type the title of the conference paper using Arial Bold point size 14 font.
- Type the author's name (and co-author's names, as applicable) in Arial point size 11 font. Show each person's affiliation and use footnotes to reference each author.
- Reference the contact information of each person with respect to each footnote below the author line
- Use Arial point size 11 font for the body text.
- Justify the text in the abstract at both the left and right margins.
- Leave one blank line between paragraphs.
- Do not indent the first line of the paragraph.
- Since the page number will added to the Word file shortly before publication, do not place anything in the footer section of your abstract.

Please keep the body text of your abstract under 300 words so that it will fit on one page easily. Do not include figures, table or photographs.

#### Submission Deadline

Submit your abstract(s) by no later than October 1, 2012.
