For your abstract submittal, you will be asked to provide the following:

- An abstract, 300 words or less
- Contact information for all presenter(s), which should include address, phone number, and email address. Note: This information will be included in conference publications.
- Whether you would like to present an oral or poster presentation. Please note that we have limited space for oral presentations; if you are not selected for an oral presentation you will be given the opportunity to do a poster presentation.

Please prepare your abstract submission online according to the Instructions for Abstract Submittal.

Oral Presentations

Oral presentations will be roughly 20 minutes in length, followed by 3 to 5 minutes for questions. If your abstract is accepted, you will receive additional information regarding presentation logistics.

Poster Presentations

Poster presentations are strongly encouraged as they allow extended informal discussions and active participation of co-authors. They will be displayed throughout the conference week. We strongly encourage poster presenters to attend the formal poster session on Tuesday, March 12 from 6:00 pm to 8:00 pm. All oral and poster presenters must pay for conference registration unless awarded a scholarship.
